
1. The Non Certified Administrator shall be employed as the Corporation Food Service Director for the school term beginning **July 01, 2025** and ending on **June 30, 2026**.
2. The school term described in paragraph 1 immediately above for services under this Contract consists of **204.00** days.
3. The number of hours per day the Non Certified Administrator is expected to work under this Contract is **7.50**.
4. The Corporation shall pay the Non Certified Administrator for services under this Contract the total salary of **\$62,000.00** during the school year.
5. The Corporation shall pay this amount in **26** installments on a **Biweekly basis**.
6. This Contract may be cancelled during its term for legal grounds afforded the Corporation per Indiana Code.
7. This Contract is a public record pursuant to Ind. Code.
